**Schedule B** is a Schedule of Non-NFA Assets you own that you might decide to transfer to your Gun Trust. There is no requirement that you have to transfer non-NFA firearms to your Gun Trust, and Schedule B is never sent to the A

Your trust transfers and conveys \$10 in cash and also other assets to "fund" your trust, making it legally effective on the date signed by you as Trustmaker. An assignment of **non-NFA** firearms and firearms accessories is also provided for your convenience and as additional documentation.

Transfers of **NFA firearms** require a BATFE approved transfer in order to become trust property or to be distributed from the trust to any other person or entity.
